### Work in Progress, 2010:

Post-traumatic Fiction: Gender and Abjection in Woolf, Joyce, and Lawrence is an interdisclipinary project that draws on psychoanalysis and feminist theory to investigate pivotal questions evoked by the intersection of trauma studies with modernist innovations in literature and film. If the 20th century is marked by historical trauma, how have cultural shock and bereavement resonated in aesthetic experiments over the last one hundred years? To what extent have modernist revolution, avant-garde transgression, and postmodern iconoclasm affected the transformation of signifying practices in the wake of epistemological crisis? This work differs considerably from earlier millennial studies, such as David Trotter's Paranoid Modernism, Kirby Farrell's Post-traumatic Culture, or Madelyn Detloff's Persistence of Modernism insofar as it uses feminist and psychoanalytic theory to analyze 20<sup>th</sup>-century narratives imbued with pervasive symptoms of post-traumatic stress.

*Trauma Narrative*. A study of fictionalized trauma narratives in twentieth century literature by women, with chapters discussing "Inscriptions on the Body," "Sexual Surrender," "Moments of Madness," and "Childhood Sexual Abuse." Authors include Virginia Woolf, Janet Frame, Margaret Atwood, Christina Stead, Maya Angelou, and Dorothy Allison.
